Mr. Gray: Mr. Speaker, I simply want to say that the press report in question appears to be based on some misunderstanding of the information the reporter in question was given. Therefore I do not think a further reply by me to the hon. member's question would be relevant.

STEEL PRICE INCREASES—REQUEST FOR INVESTIGATION

Mr. Don Blenkarn (Peel South): Mr. Speaker, I wish to address my question to the Minister of Consumer and Corporate Affairs. In view of the fact that, according to the Steel Company of Canada, steel prices will rise on April 2 by \$6 a ton, the third increase in six months, is the minister prepared to investigate this price rise to determine if it is really justified?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): Mr. Speaker, to the extent that the report in question may have some relevance to the existing combines law, I am certainly happy to draw this fact to the attention of the officials who administer that law.

Mr. Blenkarn: The industry is saying that the real reason for the price increase is the rise in scrap metal prices.

Mr. Speaker: Order, please. The hon. member should ask his question.

Mr. Blenkarn: Will the minister investigate scrap metal prices to determine if that is the true cause?

Mr. Gray: Mr. Speaker, I will draw this further comment of the hon. member to the attention of the officials administering the Combines Investigation Act.
