#### COMMITMENT OF CANADIAN PEACEKEEPING FORCES SUBJECT TO PARLIAMENTARY APPROVAL—MOTION UNDER S.O. 43

Pearson on March 13, 1964, on the deployment of peacekeeping forces to Cyprus, shall not make a commitment of forces to a peacekeeping mission without the express consent of this House by affirmative resolution.

# SUGGESTED DEDUCTION FOR VOLUNTARY FIREMEN—MOTION UNDER S.O. 43
