## COLLEGE REPORTS.

On motion of Principal Grant, seconded by Mr. S. Houston, the Assembly agreed that the presenting of the Reports on Colleges should be the first order of the day for this afternoon.

The hour of adjournment having arrived, the Assembly adjourned, to meet again at half-past two o'clock, which was publicly intimated from the Chair, and the Sederunt was closed with the Benediction.

## THIRTEENTH SEDERUNT.

On the same day, and at the same place, at half-past two o'clock in the afternoon :-

The Assembly met, and was constituted with devotional exercises—Dr. J. B. Fraser, at the Moderator's request, offering prayer.

The Minutes of the Morning Sederunt were read and sustained.

## COLLEGE REPORTS.

The Assembly called for the Reports of the Beards of the several Colleges of the Church.

Manitoba.—The Report of the Board of Management of Manitoba College was presented in printed form by Professor Hart, and was held as read. Professor Hart then directed attention to the condition of the College, and to the decided and encouraging impulse given to the work by the appointment of Principal King; and mentioning especially the devotedness and zeal with which, during the past year, the Principal had given himself to the duties of his office. On motion of Mr. James Robertson, duly seconded, the Report was received and adopted. Further,—That the Assembly record their gratification at the improved position and prospects of Manitoba College, and their high appreciation of the services rendered by Principal King, and of the efforts now being made to improve the financial condition of the College, and that they commend it to the continued liberality of the members of the Church.

KNOX.—The Report of the Board of Management of Knox College was presented in printed form by Mr. W. M. Clark, the Chairman of the Board, who directed attention to several important points therein, and especially in regard to its financial condition, and the progress of the scheme for the full endowment of the institution, and closing with the suggestion of the duty of increasing the salary of the Principal of the College.

On motion of Mr. Clark, duly seconded, the Assembly agreed, unanimously, to receive and adopt the Report of the Board of Management of Knox College, and make the salary of the Principal of the College three thousand dollars (\$3,000) per annum, commencing at the beginning of our present financial year.

## ENDOWMENT-KNOX COLLEGE.

The following resolution was submitted by Principal Caven, seconded by Principal Grant, and unanimously adopted:—That the Assembly express satisfaction with the progress made in the canvass for the Endowment Fund; again commend the Endowment Scheme to the liberality of the Church; instruct the Board of Management to complete the canvass without unnecessary delay; and direct Presbyteries and congregations to assist the Board, as they have been doing, in making the canvass successful throughout the constituency of the College.
