

Eldridge and Warren and a couple more soldiers whom we didn't know, and turned toward Borden. We stopped at the HOW lines first where these soldiers we didn't know got off and then drove to the Fire Hall where I stopped and let Casperec out. Sjt Eldridge then said to drive to the Mess calling from the back and I drove to the Mess, stopped on the left side of the road where Warren and Eldridge got out and then a couple of pro came alongside about a bright light on the truck. The pro also took the number of the truck and ordered me to follow him to the fire hall where I gave him my Pt II paybook from which he took my number and name, and then the Orderly Sjt put me in arrest and I was taken to the Cd Room. When Warren was picked up the first time he was under the influence of liquor but not drunk - I didn't talk to him after picking him up at the Star pub - nor to Eldridge.

- Q. When in dtn Sat night did you have any visitors?
A. Yes, Sjt Eldridge, I don't know if he was alone or not as it was dark. He came in and wakened me and said to me "if you take the rap we will pay you any amount of money you will lose" and that he and Sjt Warren would pay for it.
- Q. Any other visitors the days following?
A. Yes, Eldridge again on Sun morning before dinner, and he said the same things as he said that night, if I would take the rap they would give me any amount of money I would lose.
- Q. Any other occasions?
A. Yes, somebody came over and said a constable wanted to see me, a civilian constable, who wanted me to make a statement of the accident. I made this statement in front of an offr. Mon morning Sjt Eldridge called upon me to make out an accident report and we both made it out, he writing it. I asked him to sign his name on the report and he said he didn't want to sign at that time but that if it came to a court-martial he would.
- Q. Anybody else present on the occasion of these visits?
A. No, Sir, but on Sat when he came he was under the influence of liquor, but on Sunday he was sober.

CROSS-EXAMINED

- Q. When Sjt Eldridge is not in charge of the station from whom do you take your orders from?
A. L/Cpl Flamonden, Sir.
- Q. Who was IC on the Sat in question?
A. I wouldn't know. I've no idea who was in charge, I thought it was the Sjt IC in fact.
- Q. Then at no time during that day did Cpl Flamonden give you any orders?
A. No, Sir.
- Q. That was Sjt Eldridge's day off?
A. I don't know.
- Q. But you are not aware who was on duty, the duty NCO?
A. No, Sir, and with the organization that is there I've no way of knowing it. Sjt Eldridge is in charge of the fire station under Lt Duke.
