



THE MAGDEBURG

The dynamite steamship Madgeburg, from the stern of which the German flag flies, is anchored in Gravesend The dynamic steamsnip Madgeburg, from the stern of which the German flag flies, is anchored in Gravesend Bay, New York, with a cargo of dynamite, for Germany. The ship has been in the harbor for several months. Several new anchorages have been suggested by the army engineers of New York, who fear some impact may cause considerable damage to both the ship and grew. Several of the places suggested, have been objected to by the captain of the boat, who says the Madgeburg must have twenty-five feet of water to keep her cargo safe. These objections have worried the engineers considerably and they are basily looking for a place for the ship to anchor that will satisfy the captain and the people who live near where the boat is to be anchored,
