## SUMMER EMPLOYMENT FOR STUDENTS

**Mr. W. B. Nesbitt (Oxford):** Mr. Speaker, I have a question for the Minister of Manpower and Immigration. Some days ago I asked the minister whether he would make a statement on motions concerning plans with respect to employment for students during the summer months in view of the widespread unemployment in this field. The minister indicated he would do so. Can he tell us when he may be in a position to make such a statement and, if so, can he advise the house whether additional student loans may be available to students this fall in consequence of their present financial difficulties?

**Hon. Allan J. MacEachen (Minister of Manpower and Immigration):** Mr. Speaker, I shall be happy to report to the house either by making an oral statement or by tabling a report early this week. As the hon. member knows, the administration of student loans is not the responsibility of the Minister of Manpower and Immigration.

**Mr. Nesbitt:** I realize that the minister has no direct responsibility for the administration of student loans but perhaps, with his manpower portfolio in mind, he would consult the Minister of Finance—

**Mr. Speaker:** Order, please. I have reservations about questions which suggest that ministers should consult with their cabinet colleagues, or questions which inquire whether a minister has consulted with another

## REQUEST FOR PUBLISHING OF DIRECTIVES IN FORCE AT BORDER POINTS
