The said Company shall and are hereby required and di- Certain offirected to take sufficient security, by one or more bond or bonds, in a suf- cers to give ficient penalty or penalties, from their Managers and Collectors for the time being of the money to be raised by virtue of this Act, for the faithful 10 execution by such Managers and Collectors of his and their office and offices respectively.

XLVI. All fines and forfeitures imposed by this Act or which shall Fines how to be lawfully imposed by any By-laws to be made in pursuance thereof, be recovered. (of which By-laws, when produced, all Justices are hereby required to 15 take notice) the levying and recovering of which fines and forfeitures are not particularly herein directed, shall, upon proof of the offence before any one or more Justice or Justices of the Peace for the District, either by the confession of the party or parties, or by the oath or affirmation of any one credible witness (which oath or affirmation such Justice or 20 Justices are hereby empowered and required to administer without fee or reward,) be levied with costs by distress and sale of the offender's goods and chattels, by warrant under the hand and seal or hands and seals of such Justice or Justices and all such fines, forfeitures or penalties by this Act imposed or authorised to be imposed, the application whereof is not 25 hereinbefore particularly directed shall be paid into the hands of the Company, and shall be applied and disposed of for the use of the said Canal or undertaking, and the overplus of the money raised by such distress and sale, after deducting the penalty and the expenses of the levying and recovering thereof, shall be rendered to the owner of the goods so 30 distrained and sold; and for want of sufficient goods and chattels whereof Imprisonment to levy the said penalty and expenses, the offender shall be sent to the for want of common gaol for the district wherein he is convicted, there to remain tels. without bail or mainprise for such term not exceeding one month, as such Justice or Justices shall think fit unless such penalty and forfeiture, and 35 all expenses attending the same, shall be sooner paid and satisfied.

XLVII. If any person or persons shall think himself, herself or Appeal given. themselves aggrieved by anything done by any Justice or Justices of the Peace in pursuance of this Act, every such person or persons may within four calendar months after the doing thereof, appeal to the Justices of 40 the Peace, at the General Quarter or General Sessions to be holden in and for the District.

XLVIII. If any action or suit shall be brought or commenced Limitation of against any person or persons for anything done or to be done in pursuance actions for of this Act, or in the execution of the powers and authorities or by the things done 45 orders and directions hereinbefore given or granted, every such action or under this Act. suit shall be brought or commenced within six calendar months next after the fact committed, or in case there shall be a continuation of damage, then within six calendar months next after the doing or committing such damage shall cease and not afterwards.
