Exchange of Notes between the Government of Canada and the Government of the United States of America constituting an Agreement concerning the administration of income tax in Canada affecting employees within Canada of the U.S.A. subject to such taxation.

Ottawa August 1 and September 17, 1973.

In force September 17, 1973.

### Multilateral

Declaration on the Provisional Accession of the Government of the Philippines to the GATT.

Done at Geneva August 9, 1973.

Entered into force August 9, 1973.

Signed by Canada September 4, 1973.

Protocol extending the Arrangements regarding International Trade in Cotton Textiles from September 30, 1970, to September 30, 1973.

Done at Geneva June 15, 1970.

Canada's agreement to extension of this Agreement from October 1, 1973, to December 31, 1973, communicated to the Secretary-General of GATT September 21, 1973.
