THE TITANIA READY FOR SEA.

A Valuable Cargo of Salmon and Furs Worth Over a Quarter of a Million Dollars.

Yesterday morning the British clipper ship Titania, Capt. Dunn, took her freight to the old country. The cargo consists of salmon and furs valued at over a quarter of a million dollars. The Titania is under charter to Messrs. Findlay, Durban & Brodie, but carries to the order of her owners, the Hudson's Bay Co. in London, eighty-five tons of miscellaneous stores, shipped from Victoria, worth about \$100,000. With favorable weather Capt. Dunn expects to arrive in port in 100 days or even less.
