**The Sick and Funeral Benefits.**

The Sick and Funeral Benefits are optional.

The Benefits are as follows:—(1) During each separate continuous sickness, a payment of \$2.00 a week for the first two weeks; \$3.00 a week for the next ten weeks; and at the discretion of the Executive Council a further sum of \$6.00 a week for the next twelve weeks; (2) A payment of \$50 towards funeral expenses, on the member's death, to his beneficiary.

To secure these benefits it is necessary to pay an Enrollment Fee of \$1.00 and a Registration Fee of \$1.00.
