The Order of the Day being called for the second reading of the Bill (G), intituled: "An Act to amend an Act respecting Vancouver, Victoria and Eastern Railway and Navigation Company, The Nelson and Fort Sheppard Railway Company, and Great Northern Railway Company," it was—

Ordered, That the said Order of the Day be postponed until to-morrow.

Pursuant to the Order of the Day, the Senate resumed the adjourned debate on the motion of the Honourable Senator Campbell:—

That a Special Committee of the Senate be appointed to examine into the provisions and workings of the Income War Tax Act and The Excess Profits Tax Act, 1940, and to formulate recommendations for the improvement, clarification and simplification of the methods of assessment and collection of taxes thereunder and to report thereon;

(2) that the said Committee be composed of the Honourable Senators Aseltine, Beauregard, Bench, Buchanan, Campbell, Crerar, Euler, Farris, Haig, Hayden, Hugessen, Lambert, Léger, McRae, Moraud, Robertson, Sinclair, and Vien;

(3) that the said Committee shall have authority to send for persons, papers and records.

After debate, it was-

Ordered, That further debate on the said motion be adjourned until to-morrow.

Pursuant to the Order of the Day, the Senate resumed the adjourned debate on the consideration of His Excellency the Governor General's Speech from the Throne at the opening of the present Session of Parliament, and the motion of the Honourable Senator Robinson, seconded by the Honourable Senator Dupuis.

That the following Address be presented to His Excellency the Governor General to offer the humble thanks of this House to His Excellency for the gracious Speech which he has been pleased to make to both Houses of Parliament, namely:—

To His Excellency Major-General the Right Honourable the Earl of Athlone, Knight of the Most Noble Order of the Garter, a Member of His Majesty's Most Honourable Privy Council, Knight Grand Cross of the Most Honourable Order of the Bath, Grand Master of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Royal Victorian Order, Companion of the Distinguished Service Order, one of His Majesty's Personal Aides-de-Camp, Governor General and Commander-in-Chief of the Dominion of Canada.

MAY IT PLEASE YOUR EXCELLENCY:

We, His Majesty's most dutiful and loyal subjects, the Senate of Canada, in Parliament assembled, beg leave to offer our humble thanks to Your Excellency for the gracious Speech which Your Excellency has addressed to both Houses of Parliament.

After further debate, and-

The question of concurrence being put on the said motion, it was resolved in the affirmative, and—

Ordered, That the said Address be presented to His Excellency the Governor General by such Members of this House as are Members of the Honourable the Privy Council.
