Shaw, Pictou Lodge, Munroes labels of the premises must carry adequate directions for use which include directions for mixing, maximum amount of the drug to be fed per head per day and a withdrawal period of the medicated feed prior to slaughter of the animals.

2. The feed manufacturer is required to register the stilbestrol-containing feed under The Feeding Stuffs Act before its sale.

3. There is no requirement to mark the carcasses which have been fed stilbestrolcontaining feeds.

4. No ill effects from the consumption of meat from animals that were fed stilbestrol have been reported. Market surveys have been made using very sensitive methods and no detectable residues of stilbestrol have been found in the edible tissues of cattle that had been fed stilbestrol-containing feeds.

INDUSTRY DESIGNATED AREA PROGRAM. MANITOBA

Question No. 422-Mr. Stefanson:

1. Is the southern portion of the interlake area of Manitoba, including Teulon, Stonewall and Selkirk, excluded from the industry designated area program and, if so, on what basis?

2. Are areas such as Grand Rapids, Norway House and other such points in northern Manitoba excluded and, if so, on what basis?

3. Is the government now giving consideration to including the areas mentioned in (1) and (2)above, in the industry designated program?

Hon. C. M. Drury (Minister of Industry): 1. Census division 12 in Manitoba represents that part of the interlake region of Manitoba which is designated under the area development program. It does not include Teulon and Stonewall, which are in census division 9, or Selkirk which is in census division 5. Census divisions are designated where the average annual non-farm family income was reported as being below the qualifying level of \$4,250, provided they are contiguous to NES areas which also qualify for designation, and which together with these areas form economic regions. Census division 12 met this criteria, having an income level of \$3,423, and being contiguous to the designated NES area of Dauphin.

Census divisions 9 and 5 are considered to be within the broader labour market area of greater Winnipeg, where unemployment is relatively low, incomes generally higher than the Canadian average of \$5,449 and there has been a greater rate of employment growth than that experienced by the nation as a whole. They did not, therefore, meet the criteria for qualification.

2. Grand Rapids, Norway House and other adjacent points around the northern end of Lake Winnipeg are located in census division 16, which, although contiguous to the designated NES area of The Pas, has not been designated because the reported average annual non-farm family income of \$4,518 is above the qualifying level of \$4,250.

3. The area development program is being reviewed on a continuing basis by the government. Pending the availability of new data on family income late this year or early 1967, it is not planned to alter present designations.
