2. In the same period, what expenditure has been made for signal protection devices?

3. Will the government consider increasing these grants as a centennial project in 1967?

Mr. J. A. Byrne (Parliamentary Secretary to Minister of Transport): The Board of Transport Commissioners for Canada advise as follows: 1. During the calendar year 1965 the Board of Transport Commissioners authorized the payment of \$8,874,292.34 from the fund to assist in the actual construction of overhead bridges, subways and railway highway diversions which eliminated level crossings.

2. During the calendar year 1965, the board authorized payment from the Fund of \$2,891,876.98 for the installation and improvement of automatic protection devices.

In addition to the two amounts stated above \$1,040,091.84 was paid out of the Railway Grade Crossing Fund for the reconstruction of inadequate grade separations, improvements to grades and vision at crossings, the installation of reflectorized crossing signs and the placing of reflective markings on railway box cars.

The board also authorized commitments to be made against the Railway Grade Crossing Fund in the amount of \$17,231,674.95 to aid construction work for the protection, safety and convenience of the public in respect of highway railway crossings, during this same period.

3. No information is available in so far as the Board of Transport Commissioners is concerned.

In the Dartmouth area—HMCS Shearwater, RCN Armament Depot, Albro Lake Radio Station, RCN Diving School—French Cable Wharf, Shannon Park—Married Quarters.
