**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I am not at all informed about this matter except to the extent that the Minister of Manpower and Immigration told me yesterday that he would handle it in the House if questions were asked of him. I am sorry the hon. member did not think of asking a question yesterday when the responsible minister was here.

**Mr. Baldwin:** On that point, Mr. Speaker, I gave the Prime Minister, or the minister, until the weekend to make a statement and he did not see fit to do so. However, I would ask this supplementary question. In view of the fact that officials of the Department of Justice in Washington are alleged to have stated to representatives of Canadian newspapers today that for the last two years Canada and other countries have been used as a haven for people of this character in at least 50 instances, through the medium of United States corporations with subsidiaries in Canada, will the Prime Minister ask the Minister of Manpower and Immigration, because of these serious allegations, to make a further investigation and a full statement to the House?

**Mr. Trudeau:** Mr. Speaker, I am very grateful to the hon. member for having given me to the weekend to make a statement. I will give him a few more days to ask the minister the question when he is in the House.
