ANTI-INFLATION ACT

MEASURE TO PROVIDE FOR RESTRAINT OF PROFIT MARGINS, PRICES, DIVIDENDS AND COMPENSATION

The House resumed, from Monday, October 20, consideration of the motion of Mr. Macdonald (Rosedale) that Bill C-73, to provide for the restraint of profit margins, prices, dividends and compensation in Canada, be read the second time and referred to the Standing Committee on Finance, Trade and Economic Affairs.

Mr. Arnold Peters (Timiskaming): Last night, Mr. Speaker, I was pointing out that the bill before us is a unique piece of legislation. It contains very little detail, though its implications are far reaching. All the operative portions of the measure will be carried out by regulations through a board which is yet to be established. The result will be a number of actions which have not been carried out before except under extraordinary legislation such as the War Measures Act or the wartime prices and trade legislation implemented under the provisions covering peace, order and good government.

As to the constitutional aspects of the measure, we know that a meeting was called between the Prime Minister (Mr. Trudeau) and the premiers of the provinces, though I doubt any attempt was made at that time to go into any detail. Indeed, it is not likely that any details were available; there were obviously none when the bill was drafted. We shall all have to await the regulations. The bill allows for the investigation of individual tax returns of corporations and individuals, something which is altogether abnormal in our society. It also provides for a number of exemptions, though the particulars are not spelled out in the bill.

Today we are faced with a postal strike, partly as a result of this legislation although it is not yet in effect.
