PLAN TO CONTROL POSSIBILITY OF INTRODUCTION OF LASSA FEVER DURING 1976 OLYMPICS

Question No. 4,124-Mr. Robinson:

Does the government have a contingency plan to control the possibility of introduction into Canada of "lassa fever" during the 1976 Olympics from countries where this disease is prevalent?

Hon. Marc Lalonde (Minister of National Health and Welfare): A detailed Canadian Quarantine Contingency Plan, specifically directed to the containment and control of the four major quarantinable diseases, smallpox, cholera, yellow fever and the plague, has been developed by the Department of National Health and Welfare in consultation with the Provincial Departments of Health; the guidelines therein form the basis for action in the event of the inadvertent importation at any time of such dangerous communicable diseases as lassa fever. Constantly updated contingency plans exist to deal with the possibility of the introduction into Canada of "lassa fever" during the 1976 Olympics, including the emergency adaptation of existing isolation facilities.
