ARMENIAN RIGHTS IN AZERBAIJAN

Hon. André Ouellet (Papineau-Saint-Michel): Madam Speaker, I would also like to table other petitions sent to me by the Conseil des droits arméniens du Canada.

These are signed by residents of the Montreal area, specially from my constituency as well as from the ridings of my colleagues of Saint-Denis and Saint-Laurent. They are asking the government of Canada to call upon the Soviet authorities and firmly ask them to recognize the rights of the Armenian people in Azerbaijan.

GOODS AND SERVICES TAX

Mr. Alfonso Gagliano (Saint-Léonard): Madam Speaker, I have the honour and the pleasure to table this afternoon 24 petitions signed by 1,650 people, who are opposed to the goods and services tax, which they submit is a regressive tax which will cost several thousand jobs to Canada.

Also, Madam Speaker, with your permission, I would like to table 20 more petitions signed by 1,099 residents from my constituency and the Montreal area. These people oppose the new goods and services tax bacause it will cause severe and unfair hardship to low and middleincome Canadians.

Mr. Don Boudria (Glengarry-Prescott-Russell): Madam Speaker, pursuant to Standing Order 36, I have the privilege to table petitions signed by hundreds of Canadians who object to the federal government's plan to impose a new tax on goods and services which will be unfair to my constituents and all Canadians.
