That Bill C-26 be amended by deleting Clause 10.

Mrs. Marlene Catterall (Ottawa West) moved:

Motion No. 16.

That Bill C-26 be amended in Clause 10 by striking out lines 22 to 30 at page 5 and substituting the following therefor:

"(2) For the purposes of subsection (1), selection according to merit shall, except in particular prescribed circumstances, be based on the competence of each person being considered in a competition for appointment as measured against the competence of the other person or persons also being considered in the competition, except that the Commission may prescribe by regulation circumstances in which selection according to merit would be inappropriate in view of the nature of the responsibilities of the position to which the person is to be appointed and in which selection may be based on the competence of a person being considered for appointment as measured by such standard of competence as the Commission may establish without being measured against the competence of other persons."
