House goes into committee, 131, 156, 158, 167, 170, 183, 185. REPORT 130 RESOLUTIONS, 198. Motion, in amendment to the 69th (Toronto House of Industry), expressing regret that the grants for Hospitals and other Charitable Institutions are less than in previous years, 205. Negatived, 206. Motion, in amendment to the 118th (Sorel Hospital), that in view of the reduction in the grants to Hospitals, it is inexpedient to make any new grant this year, negatived; Resolutions agreed to, 207. Motion, that the Speaker do now leave the Chair; Amendment proposed, That while cheerfully granting the Supplies, the House regret that Parliament should separate without an opportunity having been afforded them, of adopting measures for equalizing the revenue and expenditure of the Province, 243. Considered, 244, 249. Motions to adjourn debate thereon negatived, 245 to 248. The amendment negatived; House goes into committee, 250. Report 5 Resolutions, for granting \$18,000 (Toronto Gaol) out of the U. C. Building Fund,—\$15,000 (Quebec Gaol) out of the Quebec Building and Jury Fund,—\$4,000 (Kamouraska Gaol) out of the Kamouraska Building and Jury Fund,—and \$3,909,454.27 out of the Consolidated Revenue Fund; and authorizing \$1,500,000 to be raised on Provincial Stock or debentures; Agreed to, 253.
