### Profiteering in Sugar is Now a Criminal Offense

OTTAWA, June 18.—Speculating in sugar is now an indictable offence in Canada, the Board of Commerce has issued an order restraining refineries from selling to other than wholesale, manufacturers, or retailers; wholesalers from selling to other than manufacturers or retailers; retailers from selling to other than manufacturers and consumers other than in quantities greater than the normal requirements of trade or household—and all other persons from selling sugar in excess of the reasonable requirements of the buyer's household.

The profit which sugar dealers may make is restricted to two cents per pound, or five per cent. The practice of advancing prices on stocks when refiners' prices advance is prohibited, and the system is ordered of fixing the price of sugar at a profit of five per cent. based on the average invoice cost of all sugar in stock at the time of sale.

Two cents per pound over refiners' prices at Montreal, Chatham or Vancouver, central points for the three District of the Dominion, is declared to be the maximum profit.

**Drastic Regulations**

Drastic regulations are made for the handling of raw sugar. The Canadian refineries are forbidden to sell raw sugars, acquired up to September 30th next, except to another refinery or with special permission from the Board of Commerce. Refineries are required to file with the board copies of every contract for raw sugar.

All the foregoing regulations are effective until September 30 next, and persons concerned may file any objection they have to make with the board which promises to make special orders where justice and reason demand. The order is made a regulation under section 26 of the Board of Commerce Act and persons indicted under this regulation will be prosecuted by the attorney general of the province in which the offence is committed.

### Auto Driven By Girl Crushes Two Men

Two Retired Merchants Killed.

NEW YORK, June 7.—A big touring car with a twenty-year old girl at the wheel left the roadway in Broadway at 151st Street yesterday, snapped off a fire hydrant and a post and crushed two elderly men against an apartment house wall, killing them instantly.

Just before noon, Miss Mariam Ep-

mann told her father, Mark Epmann, a salesman of 65 West 162nd Street, that she was going to a riding academy in the Sixties near Central Park for a jaunt through the park. She took her father's big car and started. While going down Broadway Miss Epmann saw a car draw out of 151st Street and head East. She signalled to the other car but the driver did not stop. The girl fearing a collision, swerved sharply to the right.

On the corner, partly concealed behind the fire alarm post were Homer Gibson, 65, a retired dealer in electrical supplies, and Jacob Zineman, 63, a wealthy retired jeweler. The jeweler and Mr. Gibson, previously unacquainted, had met at 151st Street, when Mr. Gibson stopped to admire

Mr. Zineman's collier. Just as Mr. Gibson bent to pet the dog's head, the Epmann car fairly jumped out of the roadway and crashed into the post and hydrant. Then it crushed the men against the wall.

Miss Epmann, pale and trembling, backed the car out and into the roadway. Policeman Joseph Quevedo, two blocks away, saw the crash and summoned the Volunteer Hospital ambulance. Then he arrested the girl. After her father had joined her at the 152nd Street Police Station, Miss Epmann was arraigned in the Washington Heights Court, where Magistrate George W. Simpson held her in \$2,500 bail on a charge of homicide. On the advice of counsel, Miss Epmann made no statement about the accident.
