Today Offers the Unionists a Good Chance to Make Gains, As Twelve London Seats Are Polling in a Most Unique Election.

In Their Talks of Protection and Are Deliberately Putting Those in Divisions Where They Will Be Defeated Who Are Likely To Make Trouble if Balfour Is Elected.

London, Jan. 15.—Of the 76 seats listed today, 19 went Unionist at the last election and 57 went Liberal and Labor. The proportion was 1 to 3—just about the proportion of the whole House before dissolution.
