2. Property not for sale. Each successful applicant will be issued an agreement for one year under which he will be required to build a cottage according to plans and specifications approved by the department. Upon completion of the cottage a licence for the lot will be issued.
3. One cottage for each of the 26 lots posted.

TIMBER LIMIT CONTRACTS

Mr. ZAPLITNY:

1. At what date did the Northern Trust company contract for timber limits 571 and 551D in the Riding Mountain National Park area?
2. What are the terms of the above contract?
3. When does the contract expire?
4. What other timber limits in Canada, if any, are there under contract between the Northern Trust company and the dominion government?

Mr. GLEN:

1. December 23, 1926, by transfer from United Assets Company of Winnipeg, Manitoba.
2. Contract by annual licence as outlined on pages 8-13 of the regulations.
3. The licence is renewable from year to year as long as there is merchantable timber as described in the licence in sufficient quantity to be commercially valuable.
4. None on dominion crown lands.

BICKLEIGH, SASK., POSTMASTERSHIP

Mr. JAENICKE:

1. Who is the present postmaster at Bickleigh, Saskatchewan?
2. Who was the postmaster at Bickleigh, Saskatchewan prior to the present incumbent, and how long did he hold this office?
3. Was the prior incumbent of the post office at Bickleigh, Saskatchewan discharged or did he resign?
4. If the prior incumbent of the post office at Bickleigh, Saskatchewan resigned, who requested his resignation?
5. Is the present postmaster at Bickleigh, Saskatchewan a returned soldier?
6. Who is the mail courier for the post office at Bickleigh, Saskatchewan; how was he appointed, and what is his remuneration?

Mr. BERTRAND (Laurier):

1. Joseph Mazzei.
2. (a) Daniel B. Brennan; (b) From 30th June 1917.
3. Resigned.
4. Because of unsatisfactory site the department was about to declare office vacant when word was received that Mr. Brennan had resigned.
5. No. The remuneration paid amounted to only \$166 plus bonus of \$14.88 per annum and no applications were received from returned soldiers.
6. W. Wade. Appointed originally in January 1938 as result of public tenders. On contractor's refusal to renew contract, temporary arrangements have been made with him to continue the service at \$674.59 per annum.

*PENITENTIARY COMMISSIONERS

Mr. JAENICKE:

1. Has the government appointed one or more commissioners under the Penitentiary Act as amended by Chapter 28 S.C. 1945?
2. If such commissioner or commissioners have been appointed has or have they taken any action under subsections A to D of section 4A of the Act, and, if so, what action?

Mr. ST. LAURENT: Mr. Speaker, the act referred to, namely chapter 28 of the statutes of 1945, is to come into force in whole or in part by proclamation. The proclamation for putting into effect that part of the act which provides that the appointment of one commissioner may be made has been under preparation and consideration since March 8, and I hope within a few days to be able not only to announce that that part has been put into force, but that an appointment has been made under it.
