We have now received a further request from the secretary general for additional assistance, and in response have agreed to assign an additional seven Canadian officers. This will bring to 20 the number of officers -in a total force of some 200-sent from Canada to help in this operation.

It is encouraging to note that so far 20 countries have been approached to provide personnel for UNOGIL, indicating the breadth of the international base that is being sought and achieved for this exercise which we believe will bring about the preservation of peace.
