HEARINGS OF ALBERTA ELECTORAL BOUNDARIES COMMISSION

Motion No. 121-Mr. Woolliams:

That an order of the house do issue for a copy of all reports, records or documents indicating the places, dates, and times of public hearings held by the electoral boundaries commission for Alberta and the members of the commission and staff attending each hearing; for a copy of the transcript the proceedings of each hearing; for a return of the record of each hearing if no transcript was made; for the memorandum provided to members of the commission who were absent from any meeting; and for the résumé or other document prepared by the commission or any of its members setting out the reasons for changes made in the electoral boundaries for Alberta.

Hon. Judy V. LaMarsh (Secretary of State): Mr. Speaker, with respect to this motion, it has already been explained to the house that the Secretary of State's department is not responsible for any of the hearings which were held by, or for the matters which took place before, the boundaries commissions. I am informed by the chief representation officer that in his opinion there is no way in which the boundaries commissions can be asked to produce such information. In some cases no records of any kind in the form of transcripts and whatnot were kept. It is therefore not within the power of the government to produce for the house the kind of documentation which is requested.

This matter was raised by my hon. friend the hon. member for Edmonton West (Mr. Lambert) while the boundaries question was this the other day, and I was just not sure being discussed in the house, and the position of the procedure by which it could be revived. was made clear to him at the time.
