## Privilege-Mr. Rossi

Mr. Rossi: My origins have been attacked and he is joking about it.

Mr. Speaker: The Hon. Member for Bourassa and the Hon. Member for Saint-Denis (Mr. Prud'homme) will stay in order.

Mr. Prud'homme: I stayed in order.

Mr. Speaker: The Hon. Member for Skeena is attempting to continue a point of order. I cannot allow that. I suggest that he may want to consult the Chair about his procedural remedies. The Hon. Member for Skeena could simply deal with this elsewhere because there is a way in which to deal with it.

Mr. Prud'homme: Mr. Speaker, I understand that you have made a ruling and I will not comment on it. However, it is also the duty of the Chair to ask Members to refrain from pursuing a debate even though they now know they can attack each other and that it will not be reported. The ongoing conversation that we heard here should also be brought to your attention—

Mr. Speaker: Order, please. The Hon. Member is attempting to comment on a ruling. He may wish to check Erskine May about the difference between private proceedings and the proceedings of the House. He may also wish to check Erskine May and its precedents with regard to matters and remedies that are—

Mr. Prud'homme: I know.

Mr. Speaker: If he knows that, what is he doing?

Mr. Prud'homme: But you should ask them to refrain.

Mr. Speaker: Will the Hon. Member for Saint-Denis come to order? The Hon. Member for Nipissing (Mr. Mantha) will come to order as well.

Mr. Prud'homme: That is exactly what we want.

Mr. Speaker: The Hon. Member for Saint-Denis will stay in order or he will push the Chair beyond its limits.

Mr. Prud'homme: But-

Mr. Speaker: Would the Hon. Member for Saint-Denis button up?

Mr. Prud'homme: No, that is not the way to talk. Now I have a question of privilege.

Mr. Speaker: The Hon. Member for Saint-Denis—

Mr. Prud'homme: You are making the question of privilege.

Mr. Speaker: Order. This is a situation that is difficult for everyone, including the Chair. I repeat to the Hon. Member for Saint-Denis that he and other Members may wish to read Erskine May on this matter with respect to the rules and references for Members with regard to private proceedings.
