Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, I have several petitions to present. I have one from Toronto, one from Thunder Bay, one from the Brampton area, and one from Newfoundland. All of the signators to these petitions condemn the Government for having deindexed family allowances. One petition lists 28 names, one lists eight names, one lists 12 names and the last one lists three names. All of the petitioners call upon the Government and Members of Parliament to maintain full indexation of family allowances so that people in the country can get what they are entitled to.

This petition comes from a number of residents of the great Province of Quebec, calling upon the federal Government to renege on this anti-Christmas notion of cutting back on the increases of family allowance. Don't let the Grinch steal Christmas. Bring back full indexation.
