Hon. Jake Epp (Minister of Energy, Mines and Resources): Mr. Speaker, I thank the House for its co-operation. In response to questions asked by the member for Prince Albert-Churchill River, I received some additional information which, hopefully, will be reassuring to the native people about whom he asked.

First, a community meeting was held last night to discuss the situation at the Collins Bay mine and the affected area. If the water is found to be unsafe for drinking, arrangements will be made for alternate water supplies.

Regional officials of the Department of Indian Affairs have been trying to contact the chief and are on their way to the community. Due to bad weather they have been delayed but should arrive shortly. We will keep on monitoring the situation.

Mr. Funk: Mr. Speaker, in response to the minister's statement, I wish to point out to him that in Cameco's release yesterday it says it was established that the monitoring equipment performed as designed and that the situation could have been reported shortly after the problem occurred. That is the information I have from Cameco.
