**THE EX-MAYOR'S APPOINTMENT.**  
It seems quite clear that ex-Mayor Fleming's appointment as Assessment Commissioner is illegal. A writ has been issued and the legality of the appointment will be tested. Under section 431 of the Municipal Act no contract between a municipality and any member of the Council of such municipality is valid. Before Mr. Fleming had resigned the Council had made a definite offer to him and he had accepted it. The contract was complete before the ex-Mayor resigned. He designedly refused to hand in his resignation until he had a tangible certainty in his hands. The public will sympathize with the Liberal party that may be taken to test the validity of this shameless appointment.

**THE RECORD UP TO DATE.**  
"A session of Parliament that is entitled to rank among the worst and most corrupt in the history of our country." Such is the characterization of the past session by The Simcoe Reformer, a journal that professes to represent the Liberal party more than the Liberal bosses and leaders. Below are some of the charges preferred by The Reformer, and they certainly are numerous enough and serious enough to scandalize the old guard of the Reform party.

First of all, there is the Drummond County Railway deal, which The Reformer denounces in unmeasured terms. The charge in this case is that the Minister of Public Works, Hon. J. L. Tarte, accepted a bribe of \$30,000 from the President of the Drummond County Railway, the bribe being given to induce the Government to purchase that railway from the owners at an extravagant figure.

The Reformer looks upon the Crown's Nest deal as a scandal, involving the honor of The Globe and Messrs. Cox and Jaffray. The old guard, however, cannot be "hypnotized" by the specious arguments of The Globe in its attempts to cover up this notorious deal. The Reformer refers to railway pass abuse, and regards the voice of Hon. Mr. Mulock "has not been heard on the subject of this act of fraud and palpable dishonesty since he entered the Government, though two sessions have gone by." Mr. Mulock, it will be remembered, made a vigorous attack on the House of Commons and throughout the country prior to the Liberal victory in June of last year.

Nor do we hear any more about extravagance at Rideau Hall. "Let us ask," says The Reformer, "where is Mr. McMullen and his former denunciations of the coal bills and every other form of extravagance and corrupt expenditure on Rideau Hall and its occupants and flunkies, and what has become of the campaign talk Liberal candidates and Liberal speakers indulged in on this once thousand morsk?"

These charges are the only ones that so far have come to the surface. With all the clamor and the noise, and the which the party have kept quiet of, what we know already is sufficient to damn the party in the eyes of all honest and respectable Canadians. The scandals involve the principal English and the leading French organs of the party, they involve some of the most reputable members of the party in Ontario, as well as he who was the power behind the throne in Quebec. And the party is only fifteen months in power! It looks as if the party will go to pieces before the next general election.

**BOY, MR. BLAIR OUGHT TO EXPLAIN.**

A company with a ten million dollar capitalization has been formed in Canada to manufacture calcium carbide. This is a product for which the demand is increasing very rapidly, especially in Europe. Canada possesses better facilities than almost any other country in the world for the manufacture of calcium carbide. We have the limestone, the coal and the required electric energy developed chiefly from water power. The Niagara peninsula is especially well adapted for the production of carbide, but it cannot be manufactured there on a large scale until the energy of Niagara Falls is available on this side of the river. However, instead of forcing the Niagara Falls Power Company to go on and develop the power agreed upon, the Government has given the company an extension of its option so that the production of electric energy on the Canadian side is one of the uncertainties of the future.

The company that has just been organized contains the names of some of Canada's leading public men. Among the list appears that of Hon. A. G. Blair, the Minister of Railways, and associated with him on the directorate we find the assistant manager of the Grand Trunk Railway, Mr. Wainwright; a director of the Drummond County Railway, William Mitchell; William Farewell, manager of the Eastern Townships Bank. The Ottawa Citizen insinuates that Hon. Mr. Blair has put no money into the concern, that the stock has been given him for his influence as a Minister of the Crown. We are not in a position to affirm or deny the insinuation, but we believe the Minister of Railways is making a serious mistake in associating himself in any way with the company. English statesmen never compromise themselves in this way and the late Sir John Macdonald afforded a brilliant example which all our statesmen should religiously follow. Sir John was never mixed

up in anything outside of politics. In view of the insinuations of The Citizen Hon. Mr. Blair owes it to himself and the country to make a statement defining his interest in the company and to defend his association in money-making ventures with railway men and others who from time to time have favors to ask from the Government and particularly from his department.

**THE VERISCOPE EXHIBITION.**  
The prize-fight pictures are really quite harmless. We do not believe they will exercise any baleful effect on the community. In our opinion the exhibition is not intended to take place this evening. If we throw a halo of mystery and secrecy about the exhibition we will excite more interest in prize-fighting than if we throw the gates wide open and make no fuss about it. In itself there is nothing whatever objectionable in the veriscope exhibition. It has any objectionable features these are indirect and secondary. It may be said that the encouragement of such an exhibition is the encouragement of actual prize-fighting, because we cannot have the phantom exhibition without having the actuality. But the veriscope pictures are much less likely to excite a taste for actual prize-fighting than are exhibitions of boxing. If we permit sparring on the stage we certainly should have no scruples in allowing the milk-and-water entertainment that was given to a representative audience on Saturday night. The veriscope is a device whereby we can see the actual prize-fighting without being contaminated by any of its vulgar surroundings. We hear no cursing, we see no disgusting spectacle. We behold merely the scientific essence of the thing.

However, we would not be surprised if the aldermen were to atone for their shameful conduct in the Fleming job by prohibiting Dan Stuart's innocent pictures.

**The John Eaton Case.**

**THE PRIZE FIGHT PICTURES.**  
City Council Will Hold a Special Meeting Monday Morning—Aldermen Opposed to Such Spectacles.—A special meeting of the City Council will be held this morning at 11 o'clock for the purpose of considering a new by-law which it is proposed to prevent the exhibition of the Corbett and Brennan prize fight pictures at the Toronto Opera House next week. The by-law reads as follows:

Whereas, in the opinion of the Municipal Council of the Corporation of the City of Toronto, no exhibition or representation of fights should be allowed in the City of Toronto; therefore, the Municipal Council of the City of Toronto enacts as follows:

(1) No exhibition or representation of any fight between individuals, or of any prize fight as defined herein, whether such exhibition or representation is given or made by pictures, drawings, photographs, models, wax works or other devices or devices, and whether exhibited or shown by means of a kinetoscope, cinematograph, veriscope, or by any other instrument or otherwise, shall be held or kept in the City of Toronto, or within the limits of the City of Toronto.

(2) In this by-law the expression "prize fight" means an encounter or fight with fists or hands, and with or without gloves, between two persons who are paid for such purpose by previous arrangement made by or for them.

(3) Any person convicted of a breach of any of the provisions of this by-law shall be liable to a fine not exceeding \$100, or to imprisonment not exceeding one month, or to both such fine and imprisonment, at the discretion of the court.

**THE BIG RUSH FOR KLONDIKE**  
Three Thousand Have Gone to That Gold Country SINCE NEWS FIRST CAME

Of the Wonderful Strikes Made Along the Canadian River.

**Numbers Taken to the North by the Different Steamers—A Freight Clerk, Who Becomes Gold Hungry, Deserts His Wife and Family—Chief Clerk of the Mint Says Some of the Reports of Gold are Exaggerated—More People Going Than Supplies.**

San Francisco, Cal., Aug. 7.—Three thousand men and women have gone to the Klondike since the Excelsior, on July 14, brought down the news of wonderful strikes there and the \$750,000, which has set a gold-hungry world crazy. Of these 1007 have sailed from this port and a few more than 2000 from Seattle. The exact number as shown by the passenger lists of various steamers that have already gone is: Cleveland 32, Unadilla 400, State of California 100, City of Phebo 85, Excelsior 110, City of Phebo (second trip) 100, Willamette 120, Walla Walla 100. Those departing from Seattle number 2032, as follows: Alki 100, Portland 87, Queen 131, City of Mexico 228, City of Topeka 236, Rosalia 150, Willamette 100, Cleveland 130, while for to-morrow, on the Eliza Anderson, 100 have been booked to sail.

Not all the expeditions which have been advertised and even arranged for have actually materialized. The Casper, which was to sail from Seattle last week, has been withdrawn, and passengers who were booked for her went on the Noyo. The South Coast of Scotia will sail in a few days for Lynn. The Farallon, which has been one of the steamers on the regular Yukon route, has been withdrawn from that service and will sail regularly in connection between Seattle and Dyea. The missionary brig Pitcairn has been sold by her owners to a party mostly from Oakland, and will sail in a few days for Lynn. She is a remarkably fast sailing vessel and was built by an organization of seven-tenths of the city's population for service in their missionary enterprise in the south seas.

**His Family for Klondike.**  
The fever and rush of the present excitement has brought to light some sad cases of desertion. One of these became known to-day when William H. Stryland, freight clerk for the Pacific Coast Steamship Company, left his wife and child and sailed for the Klondike. Stryland, who is a native of Walla Walla, has been in contact with the men who were successful from the gold fields and with those preparing to go. He caught the fever. His wife tried to dissuade him from going, but he would not be deterred. He said no more to her about the matter, but he did not tell her that he was going for the trip, either with an outfit or with money.

**Citizens of Fort Saskatchewan Ask the Federal Government to Construct One Without Delay.**  
Edmonton Bulletin, Aug. 2.—At a mass meeting of the citizens of Fort Saskatchewan, held on Thursday evening, July 29, at which F. Fraser Tims, M. L. A., was chairman, the following resolution was unanimously adopted and ordered to be transmitted to the Hon. Clifford Sifton, Minister of the Interior: "That in our opinion, and in the interest of the whole Dominion, the Federal authorities should immediately construct a wagon road and telegraph line from this point to the Upper Yukon, via the ruins of Fort Assiniboine, Lesser Slave Lake, Peace and Liard River Valley, where an almost air line can be cut, per Dr. Davidson's report of 1888, and take the whole mineral belt of the west and north at a nominal cost, the total distance from here to the Klondike in a straight line being only eleven hundred miles, while the nearest route now used is about thirty-four hundred. Our proposed route has two hundred and fifty miles of wagon road now almost ready for use, and the remainder of fifty miles is reported to be through prairie and bluff. It is a stupendous task.

**MAILS FOR THE KLONDIKE.**  
Canadian Author: I have Created a Post-office at Dawson City—Honored Police as Mail Carriers.  
Portland, Ore., Aug. 7.—L. W. Waile, Assistant Superintendent of the Railway Mail Service, has returned from a trip to Victoria, B.C., where he arranged with the Canadian mail authorities regarding the carrying of the mail in the Klondike region. He says that the Canadian authorities have created a postoffice at Dawson City. This makes three offices established by them in this portion of the Northwest Territory. The other two offices are at Forty Mile Creek and Fort Yukon. The mail will be carried by the Mounted Police from Dawson and Skagway. The service will be established in about four weeks.

**THE DUTY ON SUPPLIES.**  
Seattle, Aug. 7.—In response to a query from this city the following telegram was received from the Treasury Department: "Miners can land their goods and go to British Columbia territory from Dyea under customs supervision without payment of duty and without giving bonds." G. B. Benton has reached this city with over \$1000 worth of gold nuggets, the result of ten days' work on a Williams Creek placer claim in the Swack Creek district, Kittitas County. He has been working the claim since January, and has taken out \$5000.

**Nothing, but Kept Digging.**  
One old man who owns a claim there has been working it quietly for six years, during which time he has made about \$50,000.

**TO POLICE THE YUKON**  
Will Cost a Quarter of a Million Dollars and Government Warrants Will Have to Be Issued.  
Ottawa, Aug. 7.—It is estimated that to carry out the plans now adopted by the Government for the policing of the Yukon will entail an expenditure of a quarter of a million of dollars, a large portion of which will have to be raised by Government warrants. The claim of royalty, it is estimated, will nearly cover this cost. The strength of the force has been reduced from 750 to 650 men.
