He was employed as advising counsel in nearly every important case in the province for some years, either in or out of court, and it has been said that practically every lawyer in practice in this part of the county has consulted Dr. Earle in connection with points on which they were in doubt.

He was a most kindly man and of a generous, thoughtful disposition, giving of his time and talents to help others in the profession and seldom making a charge for his services in this regard. No man in the legal profession will be so much missed. He was employed by the government in a number of exchequer court cases, but in the last season was unable to attend on account of his illness.

Dr. Earle was a past president of the Law Society, past dean of the law school and a lecturer in the school. He was also prominent member of the Loyalist Society.

He was a son of the late Dr. Sylvester Zolbetski Earle, Jr., and his mother was Catherine McGill (City, a daughter of Captain Allen Otty, R.
