

Extracts from Act of Assembly 60, Vict. A. D. 1897.

The property to the amount of Five Hundred dollars of a wife deserted by her husband and com-pelled to support herself; and where the whole opperty owned by a widow, as well the place where she resides as elsewhere, is under the value of Fitteen Hundred dollars, and such widow supports minor children of her own or of her deceased hus-band, her property in the parish where she resudes abill be exempt from taxation to the extent of Two Hundred dollars; and air to the extent of Two Hundred dollars for each minor child wholly suppor Hudred dollars for each t ed by her. If she has no where she resides, then there she reside, then such examption shall be llowed in the slace where such property is situat-id; but such exemption shall not apply or extend without much greater provocation, for


