STEAMER SUNK BY GERMAN SUBMARINE BUILT IN CANADA

New York, Oct. 26.—A news agency despatch from London published here this afternoon says:

"A despatch from Plymouth to Lloyd's reports that the British steam- ship Donnacona has been sunk by a German submarine."

The Donnacona was a Canadian built, Canadian owned vessel which until last year was in the Great Lakes service. With the great demand for ocean tonnage since the outbreak of the European war, the Donnacona together with several lake vessels were put in the trans-Atlantic trade. She was owned by the Cana- dian Steamships Company of which Mr. James Caruthers of Montreal is the president. No statement was forth- coming from the company today.

CITY OF ST. JOHN MAKES GRANT FOR THE BRITISH RED CROSS

City Commissioners set aside space in King Square for automobiles—Mill Street at Main will be widened by removal of building.

On motion of Mayor Frink at yester- day's council meeting, it was unani- mously decided to place \$5,000 to the credit of the British Red Cross Soci- ety by the city of St. John in response to the appeal of their Majesties the King and Queen as submitted through His Honor the Lieutenant Governor of New Brunswick. The money will be made payable to the order of Lieu- tenant-Governor Wood. The amount of the grant to be levied and assessed for under 5 George, 5 chapter, sec- tions 1, 2 and 3.

Those present were Mayor Frink, Commissioners Wigmore, McLeilan, Russell and Potts with the City Clerk. The minutes of the last meeting were read and confirmed. On recommen- dation of the Mayor an order was made to pay \$35 to R. R. Burley for work done in connection with revis- ing the electoral lists for 1916. A claim by Charles A. Emery for renu- meration for services said to have been rendered in connection with the revising clerk, was referred back to the revisors for further information.

The Commissioner of Public Safety was given permission to call for tend- ers for painting the interior of the city market. On motion of Commis- sioner McLeilan the plans submitted by the Imperial Oil Co. in connection with the construction of the steel storage tank on the leasehold property in Sydney ward was approved. The council also approved of the Imperial Oil Co. putting four tanks on their property for the storage of lubricating oil only.

A request from the Automobile As- sociation that a space ten feet wide be set aside for a parking space for automobiles on the north curb of the south side of King Square was grant- ed.

On recommendation of Commissioner Potts it was decided to purchase from the Canadian Pacific Railway Co. the two-story wooden building and lot at the corner of Mill and Main streets at a cost of \$4,000 and a bond issue for this amount was allowed.

A communication from Frank D. Logan asking permission to have a sign placed on the Carleton House, West End, was referred to the Com- missioner of Public Works and the city engineer.

Grant To Widow

It was decided on motion of Com- missioner McLeilan to forward to the widow of the late George R. Barker a resolution of condolence. It was also decided to grant her the sum of \$450, being equivalent to two years' pay in the Fire Department, as a token of appreciation of the city of St. John for the faithful way in which the late Mr. Barker discharged his duties.

A communication from P. H. Butler was read, telling the council how the sum of \$15,000 annually could be saved to the city by taxing every household- er \$2 and using the money so raised for the purpose of keeping the streets clean. The letter was referred to the Commissioner of Public Works.

The Commissioner of Public Lands recommended that upon the rent be- ing paid up to the 30th day of Novem- ber next on the lot of land leased to John P. Sperdak near the West Side toll house, the license be renewed to Loula N. Berdos for another year from the 1st of December next on the same terms and conditions as the present agreement. The recommen- dation was adopted.

Leases Renewed

It was decided to renew the follow- ing leases: Lot No. 316, Brooks ward, to Robert L. Adams at \$1 per annum; one-half lot No. 1, Queens ward, to William Baxter at \$5 per annum, an advance of twenty per cent. The fol- lowing leases were renewed to Fred- erick A. Peters: Lot No. 3, Block A, Block ward, at \$9.90 per annum, an advance of twenty per cent. Lots Nos. 4, 5, 9 and part of lots Nos. 10 and 12, all in Block A, Prince ward, at the following rentals respectively: \$12.10, \$13.20, \$15.20, \$17.75, \$18.20. These renewals are all at an advance of ten per cent. A renewal lease was granted to Mrs. Julia McMann of lot No. 486, Brooks ward, for seven years from 1st November next at \$15 per annum, being ten per cent. advance over present rental.

Commissioner Russell recommended that as the agreement with the Cana- dian Pacific Railway Company, ex- tending their right to take up and re- move rails and track materials which the company has back of Nos. 1, 2, 3 and 4 warehouses, West St. John, ex- pires on the first day of November next, the same be again extended for another term of five years on the same terms and conditions. After some discussion it was decided to re- fer this matter to the Commissioner of Harbor and Piers for further con- sideration. He to take any measures necessary for the protection of the city's interests.

Red Cross Grant

In introducing his motion for the vote of \$5,000 to the British Red Cross Society, His Worship told of receiving the call for assistance and said that he had communicated with the various societies that had found themselves bur- dened with work of a similar nature that they found it impossible at that time to make any special effort as the public had been asked to contribute to so many funds that in many cases they were unable to give any further financial assistance. The Mayor point- ed out the fact that the city of St. John had so far been behind other cities of Canada in meeting the call for assistance. He thought it was up to the municipality to do this thing. The motion was supported by all the

commissioners and was unanimously adopted.

To Widen Mill Street

Commissioner Potts, speaking in support of the purchase of the two- story wooden building at the corner of Mill and Main streets from the C. P. R., pointed out that this was one of the worst corners in the city. By removing the building in question an additional fifteen feet would be ad- ded to the roadway and this would al- low for a nine foot sidewalk. The motion met with the approval of the entire council and it was decided to issue bonds to cover the cost. The money for the new roadway and side- walk at this corner would be provided for in next year's estimate.

While asking the council to approve of the plans of the Imperial Oil Co. for the tank constructed on their pre- mises, Commissioner McLeilan said he was of the opinion that it was not the safest thing to have large quanti- ties of oil stored along the harbor front. He said he intended to recom- mend the council to ask for legisla- tion to limit the amount of oil that can be so stored.

The Commissioner of Public Safety informed the council that he was securing information from concerns in the city in regards to a double dis- clock for the city market. He said the clock he had in mind would be synchronized and governed by a master clock in the Custom House.

There being no further business the council adjourned.
