*Ordered,* That the said Address be presented to His Excellency, by such Members of this House as are of the Honorable the Privy Council.

The Honorable Mr. *Tilley*, a Member of the Honorable Privy Council, delivered to Mr. Speaker, a Message from His Excellency the Governor General, signed by His Excellency.

And the said Message was read by Mr. Speaker, all the Members of the House being uncovered, and is, as followeth :—

## DUFFERIN :

The Governor General recommends to the House of Commons the appropriation, out of the Consolidated Revenue Fund, of such sums—not exceeding Five thousand dollars in the whole—as may be necessary to enable any party entitled to appeal to Her Majesty in Council on the subject of the *New Brunswick* School Acts, and desiring to institute such appeal, to defray the expenses thereof; and of such sums—not exceeding in the whole Five thousand dollars—as may be necessary to defray the expense of sending skilled manufacturers from *Canada* to the Exhibition at *Vienna*.
