branches taught, the number of pupils in each branch, and the books an annual 2 used; the average attendance of pupils, both male and female, in Contents of Summer and in winter.

4 4th.—The amount of moneys which have been received and collected in each section or part of section—distinguishing the 6 amount apportioned by the Chief Superintendent of Schools, the amount received from County Assessment, the amount raised by 8 Trustees, and the amount from any other and what source or sources; also how such moneys have been expended, or whether any part 10 remains unexpended, and from what causes; the annual salary of Teachers, male and female, with and without board.

12 5th.—The number of his and other School visits during the year; the number of school lectures delivered; the whole number of 14 School-houses, their sizes, character, furniture and appendages, the number rented, the number erected during the year, and of what 16 character and by what means.

6th.—The number of qualified Teachers, their standing, sex, and 18 religious persuasion; the number, so far as he may be able to ascertain, of private Schools, the number of pupils and subjects taught 20 therein; the number of Libraries, their extent, how established and supported; also any other information which he may possess respecting 22 the educational state, wants and advantages in each Township of his charge, and any suggestions which he shall think proper to make 24 with a view to the improvement of Schools and diffusion of useful knowledge.

VIII. School Visitors and their duties.

28 XXXII. And be it enacted, That all Clergymen recognized by law, of whatever denomination, Judges, Members of the Legislature, 28 Magistrates, Members of County Councils and Aldermen, shall be School Visitors in the Townships, Cities, Towns, and Villages where 30 they shall respectively reside: Provided always, that persons holding the Commission of the Peace for the County only, shall not be School 32 Visitors within Towns and Cities: Provided also, that each Clergyman shall be a School Visitor in any Township, Town or City where 34 he may havepastoral charge.

XXXIII: And by it enacted, That it shall be lawful for each 36 of said School Visitors, to visit as far as practicable all the Public Schools in such Township, City, Town or Village; especially 38 to attend the quarterly examinations of Schools, and at the time of any such visit to examine the progress of the pupils, and the 40 state and management of the School, and to give such advice to the Teachers and pupils, and any others present, as he may think 42 advisable, in accordance with the regulations and instructions which shall be provided in regard to School Visitors according to law: 44 Provided always, that a General Meeting of such Visitors may be held at any time or place which may be appointed by any two Visitors, 46 on sufficient notice being given to the other Visitors in the Township, City, Town or Village; and it shall be lawful for such Visitors 48 thus assembled to devise such means as they may deem expedient for

the efficient visitation of the Schools, and to promote the establishment

50 of Libraries and the diffusion of useful knowledge.
