3. *Resolved*, That a sum not exceeding One thousand one hundred dollars be granted to Her Majesty, to defray expenses for supplying blankets to aged and destitute Indians, of *Upper* and *Lower Canada*; for the financial year ending 30th June, 1867.

4. *Resolved*, That a sum not exceeding Five thousand dollars be granted to Her Majesty, to defray expenses of Miscellaneous Printing; for the financial year ending 30th June, 1867.

5. *Resolved*, That a sum not exceeding Six thousand, five hundred dollars be granted to Her Majesty, to defray expenses for advertisements and subscriptions to the *Canada Gazette*; for the financial year ending 30th June, 1867.

6. *Resolved*, That a sum not exceeding One thousand, two hundred dollars, be granted to Her Majesty, to defray expenses for postage of the *Canada Gazette*; for the financial year ending 30th June, 1867.

7. *Resolved*, That a sum not exceeding One thousand, two hundred dollars be granted to Her Majesty, to defray expenses of the Shipping Master's Office; for the financial year ending 30th June, 1867.

8. *Resolved*, That a sum not exceeding Sixty thousand dollars be granted to Her Majesty, for unforeseen expenses; for the financial year ending 30th June, 1867.

9. *Resolved*, That a sum not exceeding Forty thousand dollars be granted to Her Majesty, for Seigniorial Indemnity to Townships; for the financial year ending 30th June, 1867.
