shape or form. May I ask the Prime Minister trade practices regarding the production, whether the Canadian government, as such, is informed when a decision of this kind by the NORAD commander is taken, and if so through what channel?

Mr. Diefenbaker: Information comes to the chiefs of staffs committee, and through the Canadian chiefs of staffs to the government, in this case to the Acting Minister of National Defence and to the Prime Minister.
