But once again, that is not the point I want to make. I am not interested in those people who would deliberately paralyze a democratic institution and then go beg for votes in the province of Quebec, through false representations and demagoguery.

Mr. André Fortin (Lotbinière): I am most pleased to contribute in a positive way to the discussion on this amendment, moved by the hon. member for Beauce (Mr. Rodrigue), amendment to delete from the bill the words: "or health".

I would like to ask the hon. member for Matane (Mr. De Bané) not to run away, to stick to his seat. It is the first time we see him since the beginning of this session. I should like him to have at least the courage of his convictions, and to remain here.

If the hon, member has a point of order and would cite the relevant Standing Order which pertains to his point of order, I would be pleased to hear it.

Let them take off their white berets.

Some hon. Members: Hear, hear.

Mr. Fortin: Mr. Speaker, after these remarks.-

Mr. C. A. Gauthier (Roberval): Stupid-

Mr. Fortin: After these remarks—which the member for Roberval (Mr. Gauthier) rightly said were stupid, to respect the decorum of the same member-I would like to come back to the proposed amendment.

I appreciated the remark of the hon. member for Matane when he told us that the Ralliement créditiste is wasting the time of the house, that the Ralliement créditiste is boycotting or filibustering the debates. I will tell him that when he makes such statements, he is entirely wrong. What we have been doing, for over fifteen days, or nearly nineteen days,—time is not important in this house, what counts, Mr. Speaker, is the legislation we pass and not the stupid speeches that can be made by the hon. member for Matane.

It will take all the time required, but when we are through, the Canadian people will recognize that the Ralliement créditiste has the courage of its convictions, that it is faithful to its constituents, and that it has made its best sincerely and honestly—and not paid to
