WAR MEASURES ACT—PROCEDURE FOR DISCLOSURE OF NUMBER AND NAMES OF PERSONS ARRESTED, CHARGES, ETC.

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I would like to ask the right hon. Prime Minister whether he would make a statement, not today of course but at the first opportunity thereafter, indicating the success of the operations under the War Measures Act, what procedure we may expect to be followed with regard to disclosure of the number of persons arrested, their names, and what the charges are, and also what assurances there may be with regard to the right to counsel and the arrangements with regard to review? Would the Prime Minister consider making such a statement?

Right Hon. P. E. Trudeau (Prime Minister): Yes, Mr. Speaker, I will gladly consider that suggestion. I am sure it will be most helpful to the House to know how the procedures under the Act are being applied. Perhaps I may have one of my ministers make a statement rather than myself. I am sure the Leader of the Opposition realizes that the regulations under the Act foresee that it is the provincial Attorney General of course, who is entrusted with the application of the Act. It will be our role to co-operate with him and to ensure that we can give him any assistance required in making certain that the regulations and the Act are interpreted along lines that the members of this House would desire.
