POTATOES—ESTABLISHMENT OF SUPPORT PRICE

UNEMPLOYMENT—FEDERAL PROGRAM TO PROVIDE EMPLOYMENT THIS WINTER

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I have a question for the Prime Minister. As the proposed meeting with the provinces is now being suggested for December, some 10 weeks away and apparently at a time that would not be useful for discussing any shared-cost programs to be effective this winter, is the government preparing a federally financed program to provide jobs or opportunities for work to be announced prior to that time?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I have always made it clear that the federal government was studying plans and projects which might be announced in due course. I believe I have always made it clear as well that these would be done, in so far as they were under federal jurisdiction, without waiting for a federal-provincial conference. It was in response to opposition requests that I said a federal-provincial conference was being convened by me. I am sorry the Leader of the Opposition found it necessary to say that I was dishonest in using the federal-provincial conference date as a way of getting out of our task of fighting unemployment. I wonder if he regrets using that word.

Mr. Stanfield: Mr. Speaker, the Prime Minister is confused.
