Hon. John C. Crosbie (Minister of Justice and Attorney General of Canada): Mr. Speaker, the Deschênes Commission did not actually request a six month extension. They wrote some weeks ago, giving us a progress report on the work they have done. They are doing a very thorough job, as the Hon. Member knows. They said they could not finish all of their work as they thought it should be done by the end of June of this year. They then set out certain options. Due to the illness of Mr. Justice Deschênes for some three months, we advised Mr. Justice Deschênes today that we would grant a further three month delay to submit the report by September 30.

As the Hon. Member knows, the U.S.S.R. did not respond to their requests to take certain evidence there. It was five months before they responded and they have not met all of the conditions that were set down. They violated the conditions by giving out to the public and the press the names of two persons who were among those to be investigated. The complete range of conditions—

RELEASE OF FUNDING

Hon. Warren Allmand (Notre-Dame-de-Grâce—Lachine East): Mr. Speaker, my question is directed to the Minister of Employment and Immigration. In a poll released today we are told that only 28 per cent of Canadians are satisfied with the Government's job-creation programs. When will the Minister start listening to ordinary Canadians and stop playing political games with these programs? With the unemployment rate at 9.6 per cent nationally and 24 per cent in the Acadian Peninsula, when will she restore the jobs budget to the same level as last year and release the moneys frozen by her Department all over the country?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, we must be doing something right with the Canadian Jobs Stategy because that is reflected in the increased number of jobs created in the last year and a half—some 630,000 jobs.

Some Hon. Members: Hear, hear!

Miss MacDonald: I want to tell the Hon. Member that, although a number of his colleagues have insisted today that we should not proceed with job creation and training in the Acadian Peninsula—

Mr. Gray (Windsor West): We never said that.

Miss MacDonald: —we will do so, as we will do whether it is in Cape Breton, sections of Newfoundland, or as we did with single industry towns like Sault Ste. Marie, Trail, and other places where unemployment is so high.

Some Hon. Members: Order.

Miss MacDonald: We will continue to operate in that way.
