# GOODS AND SERVICES TAX

Mr. Gilbert Parent (Welland-St. Catharines-Thorold): Mr. Speaker, I join with many colleagues on this side of the House to condemn the putting in place of the goods and services tax.

I have the pleasure to present a petition signed by Canadians from across Ontario and, more specifically, from my riding of Welland—St. Catharines—Thorold.

This ignoble bill is possibly going to be read into effect before the end of this year, but we as Canadians will be paying the price for it for many years to come. Once again we ask the government to reconsider and to kill this bill.

## NORTHERN TAX BENEFITS

#### GOODS AND SERVICES TAX

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, I have the obligation or the duty this morning to table five petitions dealing with the government's intention of imposing a tax on all goods and services purchased by Canadians.

The people who have signed this petition claim that the government has increased the existing federal manufacturers' sales tax from 9 per cent to 13.5 per cent over the last six years, that it will now impose a 7 per cent tax on all goods and services which will be hidden, that the imposition of this goods and services tax will cause serious and unfair hardship to low and middle income Canadians, and that the imposition of this tax will create an onerous burden on small business.

I could go on, but I will just say that these people ask Parliament, plead with Parliament, pray that we do not proceed with this very bad tax.

The British had its poll tax, and we know what happened to Madam Thatcher. This government has its GST tax, and we know what is happening to this government.

### NORTHERN TAX BENEFITS

Mr. Réginald Bélair (Cochrane—Superior): Mr. Speaker, I would like to present a petition in which the undersigned residents of my riding of Cochrane—Superior, more specifically citizens from the town of Manitouwadge, respectively requesting the federal government to reject the task force report on tax benefits for northern and isolated areas.
