- 4. In addition to regional offices, are district or other sub-offices maintained and, if so (a) in what locations (b) how many?
- 5. Are the duties performed by those manning the regional and/or district offices line functions, in the chain of command from Ottawa to the operator in the field, or do they have other functions to perform and, if so, what are such functions?

Hon. Otto E. Lang (Minister of Transport): 1. (a) The Department of Transport presently maintains 11 regional offices. (b) The locations are as follows: (i) Canadian Air Transportation Administration (CATA): Moncton, New Brunswick; Montreal, Quebec; Toronto, Ontario; Winnipeg, Manitoba; Edmonton, Alberta; Vancouver, British Columbia. (ii) Canadian Marine Transportation Administration (CMTA): Dartmouth, Nova Scotia; St. John's, Newfoundland; Toronto, Ontario; Quebec City, Quebec; Vancouver, British Columbia. (c) See maps following.
