

Mariette Wolf contradicted categori-cally the testimony given yesterday by the newspaper photographer, Barbary. She said she had never stated that she would deny everything if Madame Stein-heil was arrested. Several stormy scenes occurred dur-ing the afternoon. At one point Ma-dame Steinheil shouted defiantly that if it was true that she had received \$1,200 from her lover, Chounard, the iron manufacturer, he had made a hun-dred times that amount from clients whom she had brought him. The testimony of Mme, Wolf, as well as that of her son Alexandre, who fol-lowed her, was wholly favorable to the defendant.







Starting a Rubber Plant.

Starting a Rubber Plant. Rubber plants are usually started by a method known as mossing. A cut is made in a young branch and a wedge put in it to kep the surface apart. A bunch of sphagnum moss is then fastened around the stem over the cut, the moss being kept wet. As soon as the young mosts appear on the outside of the moss the young branch is cut off and potted up.
