Fighting their Neighbor's Liberty. The World's other morning took occasion to charge Principal Gibson and others associated with him with the serious accusation of contributing to the death rate of the people by denying them fresh air on their only day of freedom in the week. We are not alone in the position we have taken on this question. In another article we reproduce the opinion of the leading Scottish daily on the same subject. We commend the article to the attention of our readers, and especially do we ask the restrictions and the ministers of Toronto to consider the opinion of the World when it says that "A heavy responsibility lies at their doors who flinch from their neighbor's liberty, his share of sunshine and fresh air, his due recompense in burden of city taxes he bears, and his right to employ the day of rest according to his own desire and conscience, so long as he does not touch on similar rights accorded to his fellow citizens. The Substantarians of the West will find it quite as difficult a matter to free themselves from this odious as to make good their dubious and untenable reading of Moses' law in its application to the Glasgow tramway system of this year of grace. It appears that they find sufficient sanction in their consciences," which again turns out to be little else than their own predilection to opinions. "Every man," said one of them, "had a duty to his own conscience." This has been the language of the bigot and persecutor since the beginning of the world. The most enlightened of them have the most conscientious as to what they have been unable to conceive that others may have consciences as well as themselves. "Personally," said this authority, "I would take nothing, neither the day of anything else, in place of the enjoyment he possessed in being with his family on a Sabbath afternoon." But there are others who may have a greater appreciation of fresh air, and others who have less of their own predilection to opinions. Are they to be prevented from taking a run by car into the country, or even from taking part in a meeting which, although held in a City Hall instead of a church, is certified to be of a 'sacred character,' because this or the other town councillor, minister, or Sunday school teacher think that on Sunday none should go abroad except to walk on the park and back? Some horrible doubts were awakened by the discussion on Thursday as to whether the Substantarians in holding of Sunday cars had even the merits of being conscientious. The affirmation was made by one member of the council, and it did not meet with contradiction, that he had seen one of the speakers on the deputation that had waited on the corporation coming out of a Sunday car, and worse still, that the mover of the amendment—the very ball who argued that the elders and Christian workers, to put their feet down on all Sunday labor and follow the example of Edinburgh—"was once seen driving in a cab to an ordination Sunday service." There is nothing still more offensive in the public eye than intolerant Substantarianism—namely, canting hypocrisy. There is a shrewd suspicion that the two are often a good deal mixed up together in Glasgow and elsewhere. Coming from the register it is scarcely to be wondered at that a compliment to the people of the west as an example to be followed in the matter of enforced Sabbath observance, as he did very probably believe, was declared in the course of the Glasgow deputation. The Glasgow tramcars has only led us into wider excesses in those forms of Sabbath desecration that ride about the waters of a Glasgow councillor can discourage human nature. He would not pay more than a shilling for refusing to do so much as the burden of sacred music as relief from the burden of going to church and listening to sermons. Human nature in these cases always avenges itself. It will break out into the duties of the music hall. If it is deprived of its tramway car, and of the opportunity of drinking fresh air, it will take to the streets to show that the extravagance of the Glasgow corporation.

NEXT-TUESDAY BUDGET DAY.

THE PUBLIC ACCOUNTS TO BE BROUGHT DOWN WEDNESDAY.

The Reports Respecting the Agricultural College—Inquests on Inmates of Jails—The Supplying of Natural Gas to Buffalo From Canada—Various Matters.

The position presented at the Legislature yesterday were these: Municipal Council of Newmarket and North Toronto—In favor of the taxation of residents. The Municipal Council of Toronto—In favor of the maximum first and second-class railway passenger rates.

The Beeton Publishing Company, the publishers of the Newmarket Era, the Aurora Banner, the Stouffville Tribune and the Hamilton Standard, have been made the maximum first and second-class railway passenger rates.

Welland County Council—For legislation to prevent the contamination of the Niagara River by the dumping of dredging material from the harbor and the adjacent canal into the river basin. It is alleged that this has been going on for years past to the great annoyance of the residents of the basin. It is alleged that this sometimes takes place in American waters, and sometimes in Canadian waters close inshore, and that the local authorities are unable to cope with it, although repeated efforts have been made in this direction.

Hon. Mr. Gibson brought down these returns: Copy of an order in council appointing Samuel B. Sinclair, B.A., vice-principal of the Ontario Provincial Normal school, salary \$1000 per annum from Jan. 1, 1894; copy of an order in council approving of the agreement with the Methodist Book and Publishing House respecting certain Public School publications.

A detailed statement of the bonds and securities of the Ontario Provincial Normal school, as recorded in the Provincial Registrar's Office since the last statutory return submitted to the House this time.

The following bills were read the first time: To prevent the taking of natural gas from the wells by any person, other than the owner, for the purpose of selling it during infraction of such legislation, recoverable before any justice of the peace.

The effect of this bill would be to prevent the supplying of natural gas to Buffalo by the two American companies, and to force it to its destination by artificial means.

Respecting Upper Canada College, to enable the old boys of the college to appoint four members of the Board of Trustees having in their hands the control of the college, with power to recommend appointments to the staff, who are now five in number, and to elect a chairman, who shall constitute a committee of nine members.—Hon. Mr. Ross.

Respecting mortgages and the sale of property, almost purely a consolidation.—Hon. Mr. Gibson.

Mr. Ryerson enquired of the Provincial Treasurer: Has a commission been appointed to enquire into charges made by G. A. Dorian against Dr. P. H. Bryce, Secretary of the Provincial Board of Health, who are the members of the commission?

Hon. Mr. Harcourt: A commission has been appointed, consisting of Mr. Fleming, Inspector of Loans, and Dr. Ross.
