We deny that in 1821, there were only 181 communicants of the Church of England in Upper Canada; and we deny that the Report of the Society for the Propagation of the Gospel stated that to be their amount! It merely published the number as reported; and where no reports were received, a blank was placed opposite the name of the parish or mission. Moreover, it was not the custom to report the whole number of communicants within any given charge, but the greatest number at any one time; a mode of reporting which would by no means convey an accurate statement of the full strength of that particular communion. On the contrary, we know of many instances in which the whole number in one year, often more than doubles the greatest number at one time.

We have said that the Church of England in this Province numbers now at least 10,000 communicants; and we have to add, that were clergymen of that Church planted throughout the country, wheresoever they are needed and desired, that number would, in a very few years, be increased three or four fold.

DIOCESAN CHURCH BUILDING SOCIETIES.

Our venerated Diocesan has issued a circular to the clergy of his diocese, calling upon them to appeal to their respec tive flocks to assist this benevolent society. We have on several occasions announced the beneficial effects which have resulted from the exertions of the society, and are sorry to hear that its funds are at present at so low an ebb. If provision is to be made to supply the spiritual necessities of those who are destitute of gospel instruction in the populous parts of the diocese, extraordinary exertions must be used to provide church accommodation and ministers. We cannot do better than make the following quotation from his lordship's excellent letter, which at once shows the situation in which the society at present stands:-" Until it shall please God to move the hearts of our legislators to make this destitution of religious privileges the object, as it ought to be, of a nation's care and a nation's bounty, the society has to depend upon the voluntary offerings of a Christian public, in annual subscriptions, donations, bequests, and congregational collections. Next to the extent of the evil, the society has only to regret the inadequacy of its means. At this time the annual subscriptions do not exceed £1150; ordinary donations £1750; hitherto one bequest of £186; and congregational collections (variable) averaging from the commencement £903. Finding more and more, as each succeeding year brings fresh facts to light, the magnitude of the work in which they are engaged, and the necessity of continued exertion; compelled by the urgency of the cases brought before them to expend the whole of their funds, the committee, in this the fourth year of the society's existence, would impress upon the public mind the importance of a more regular and ample supply, otherwise their efforts must prove insufficient. Leaving out of account the fearful arrear of a century of past apathy, it is found, that the progressive increase of the population would require eight new churches annually in these districts, the cost of economically building and endowing which would be £32,000: and if the society were to limit its grants to one fourth of the expense, the rest being to be provided from local resources, this would require an annual income to the society of £800 to keep pace with the current
