of the Rule. The defendant should have leave to file it nunc protunc; and, upon its being filed, the judgment, if entered, is to be set aside. Costs of the judgment, if entered, and of the motion before the Local Judge and of this appeal, to be costs in the cause to the plaintiff. A. A. Macdonald, for the defendant. C. M.
