Speaker's Rulings:

1. Motion by Mr. Knowles to refer subject-matter of a divorce bill to the special committee on Procedure: Mr. Speaker stated that the reference of the subject-matter of a divorce bill would not enable the committee to enquire into parliamentary procedure in respect of divorce proceedings since the bill dealt with the dissolution of an individual marriage and, on the other hand, the committee was empowered to enquire into all procedural questions, 76.
