The following schedules of works proposed to be carried out for the relief of unemployment in the county of Megantic were submitted by the province of Quebec in accordance with the terms of the agreement entered into on July 26, 1933, between the dominion and the province respecting unemployment relief:

Schedule No. 3.—Highway No. 49—Black Lake and township of South Ireland, county of Megantic. Relocation, widening, grading and other works preliminary to the construction of a pavement. By day labour. To remedy unemployment in Thetford Mines and Black Lake: Total estimated cost, \$10,000; man-days work provided by project, 5,000; basis of contribution 50 cents per man-day, dominion proportion, \$2,500; number of unemployed, 140.

The above schedule was received on August 9, and approved by the dominion on August 16, 1933.

Schedule No. 2.—Township of Thetford south and Sacre-Coeur-de-Marie, county of Megantic. Grading, construction of culverts and gravelling on the road to St. Alphonse. Five miles. By day labour. To remedy unemployment in Thetford Mines: Total estimated cost, \$20,000; man-days work provided by project, 10,000; basis of contribution 50 cents per man-day, dominion proportion, \$5,000; number of unemployed, 394.

The above schedule was received on August 10, and approved by the dominion on October 14, 1933.

Schedule No. 4—Highway No. 1—Township of South Ireland and town of Black Lake, county of Megantic. Widening, grading and various improvements. By day labour. To remedy unemployment at Thetford Mines and Black Lake: Total estimated cost, \$10,000; man-days work provided by project, 10,000; basis of contribution 50 cents per man-day, dominion proportion, \$2,500; number of unemployed, 536.

The above schedule was received on August 10, and approved by the dominion on October 14, 1933.

Schedule No. 4A.—Megantic county—Highway No. 1—town of Black Lake, township of South Ireland and Coleraine. Widening, grading and various improvements. By day labour. To remedy unemployment at Black Lake and vicinity. (Above in addition to schedule No. 4 approved by P.C. 2113, dated October 14, 1933, for a dominion contribution not to exceed \$2,500): Total estimated cost, \$6,000; man-days work provided by project,

3,000; total estimated labour cost, \$4,800; basis of contribution 50 cents per man-day, dominion proportion, \$1,500; number of unemployed, 536.

The above schedule was received on January 8, 1934, and approved by the dominion on January 24, 1934.

Schedule No. 1.—Township of Inverness and township of Ireland-North, county of Megantic. Grading, levelling, construction of culverts and gravelling on the road to the village of Inverness. By day labour. To remedy unemployment in Thetford Mines: Total estimated cost, \$15,000; man-days work provided by project, 7,500; basis of contribution 50 cents per man-day, dominion proportion, \$3,750; number of unemployed, 394.

The above schedule was received on August 21, 1933, and approved by the dominion on October 14, 1933.

Schedule No. 238.—Ste. Anastasie de Nelson. Road works through Nelson township, Megantic county. For the needy unemployed in Ste. Anastasie de Nelson township and surrounding district. Undertaking to be carried out by the Department of Colonization: Total estimated cost, \$2,700; man-days work provided by project, 1,250; basis of contribution 50 cents per man-day, dominion proportion, \$625; number of unemployed, 42.

The above schedule was received on September 11, 1933, and approved by the dominion on October 21, 1933.

Schedule No. 239.—Nelson. Road works through Nelson township. Megantic county. For the needy unemployed in Nelson and surrounding district. Undertaking to be carried out by the Department of Colonization: Total estimated cost, \$1,000; man-days work provided by project, 500; basis of contribution 50 cents per man-day, dominion proportion, \$250; number of unemployed, 28.

The above schedule was received on September 11, 1933, and approved by the dominion on October 21, 1933.

Schedule No. 237.—St. Octave de Dosquet, Megantic county. Road works through Nelson township. For the needy unemployed at St. Octave de Dosquet and surrounding district. Undertaking to be carried out by the Department of Colonization: Total estimated cost, \$1,500; man-days work provided by project, 688; basis of contribution 50 cents per man-day, dominion proportion, \$344; number of unemployed, 38.

The above schedule was received on September 13, 1933, and approved by the dominion on October 21, 1933.
