The house has a right to this information, and I rise to urge most strongly that no minister has a right to answer in this way and thus postpone giving an answer to a question that must be answered now and with respect to which we cannot wait for the answer in view of the fact that the government has acted so improperly in so many ways.

Mr. Hellyer: Mr. Speaker, unlike the right hon. gentleman I take this matter seriously, because I think it is serious.

Some hon. Members: Oh, oh.

Mr. Hellyer: I do not think it would be in the public interest to spell out those areas which are considered sensitive, and I have no intention of doing so.

Mr. Diefenbaker: I cannot challenge the minister when he says it is not in the public interest, although I believe it is the political interest of the government he is thinking about. I ask this question. What happened in Windsor? Can he answer that? Did Paul tell Paul what should be done?
