- First reading en bloc, scrutinizing before second reading, unanimous consent, 257-8

## Introduction

- Brief explanation, 1805, 3286-7
- Explanatory note argumentative, deferring until corrected, 1154
- Financial initiative of Crown, infringing upon, 1153
  - Deferring decision, 1117-8, 1122, not clearly imposing tax or impost, giving benefit of doubt, 1153-4
  - Deferring decision, 3286, redistributing funds, not in order, 3336-7
- Possibly circumventing normal supply procedure, deferring decision, 2832-3
- Reservations as to procedural correctness of bill, subject to further scrutiny, 2294
- Scrutinizing prior to, 948, 1153

## Privilege

- Annual report, irregularities, tabled late, grievance rather than question of, 3546
- Cabinet documents, lack of investigation into leaks to press, grievance or possible foundation for non-confidence motion, not a question of, 168
- Charge against member, possibility of debating under another S.O., deferring decision, 2292-3, charge must be specific, matter for debate rather than question of, 2319
- Debate rather than question of, 1498, 1850, 1904-5, 1929-30, 2589, 3598, 3716
- Dispute with minister as to allegation of fact not a question of, 129, 1467, 1593, 2976, 3348
- Grievance rather than question of, 1071, 1655, 2627, 3285
- Indicating question briefly, 2976
- Matter already before committee, should not be debated in House, 838
- Matter more appropriately raised as statement on motions, deeming as such, 3153
- Member referred to entitled to give views, 2292
- Members, alluding to absence, grievance rather than question of, 1805
- Members involved have stated positions, matter not to be pursued further, 640, 666-9
- Minister and deputy not available to committee, difficulty should be resolved by same committee, propriety of having one committee investigate another, matter substantive, not a question of, 1849
- Minister, failure to appear in committee, should be resolved by committee, not a question of, 2127-8
- Ministerial statement released to press but not to members, not a question of, 3589
- Ministerial statements outside House, withholding of information, etc., grievance rather than question of privilege, 297
- Minister's conduct, specific charges should be made, not a question of, 2127-8
- Ministers, conflicting and misleading statements, dispute as to allegation of fact, not a question of, 2541
- Minister's statement, conflicting with departmental publication, could be raised in appropriate committee, not a question of, 410
- Misquotation, correcting, 1493
- Motion, substantive, not one of privilege, 3546
- Newspaper article, correcting inaccuracy, not a question of, 627
- No motion made, should not pursue matter further, 627, 1071, 3268
- Not a question of, 1655, 3154-5, 3217, 3407, 3585
- Notice filed, member should state case and not merely indicate support for another member's motion, 664
- Notice in writing to Speaker, 591, 838, 1675, 1965, 2627, 3268
- One at a time, 1849
- Petition, referring to committee, substantive matter, not a question of, 871-2
- Question on notice, delay in answering, not to be pursued further, minister may comment, 2929
- Raising unnecessarily an abuse of procedure, 366
- Related questions concerning official of Parliament, allowing members to indicate arguments and government spokesman to reply, 659-69; parliamentary privilege never deemed to extend to senior officials of Parliament or government, grievance may be dealt with through substantive motion or by referring matter to appropriate House committee, 707
