#### ST JOHN'S, NFLD.—RENOVATION OF FACILITIES TO ENABLE AIR CANADA TO PROVIDE SERVICE WITH TRI-STAR AIRCRAFT

In view of the statement made in Halifax by the regional director of Air Canada to the effect that they would not be able to carry out the scheduled placing into service of the Lockheed Tri-Star at St. John's airport unless the Department of Transport is prepared to carry out immediately certain renovations of the airport facilities and in view of the urgency of this question, can the minister inform the House whether the renovation of the terminal and other facilities will be carried out in time?

**Hon. Jean Marchand (Minister of Transport):** Mr. Speaker, representatives of my department will meet with Air Canada tomorrow, January 16, and I hope that as a result the problem of space requirements for the Lockheed Tri-Star can be solved.

**Mr. Reynolds:** Have environmental impact studies also been done for the Pickering airport and the St. Scholastique airport and are they ready and available?

**Mr. Davis:** Mr. Speaker, studies have been carried out with respect to those airports.
